BOARD RESOLUTION No. 10 s.2025

A RESOLUTION IMPLEMENTING GUIDELINES FOR GARBAGE COLLECTION AND THE HIRING OF UTILITY PERSONNEL TO MANAGE WASTE DISPOSAL AT THE MATERIALS RECOVERY FACILITY (MRF)

WHEREAS, proper waste management is essential for the health, safety, and cleanliness of the Bria Manolo Fortich community;

WHEREAS, to regulate the volume and schedule of waste disposal, the Association deems it necessary to implement a policy limiting the number of garbage sacks and specifying a designated dumping day and time;

WHEREAS, there is a need to hire utility personnel to maintain order during dumping, assist in segregation, and ensure cleanliness at the Materials Recovery Facility (MRF) a rate of **Five Hundred pesos (P500.00)** per day per week;

NOW THEREFORE, BE IT RESOLVED, as it is hereby **RESOLVED**, that the Bria Manolo Fortich Homeowners' Association, Inc. shall implement the following Garbage Collection Guidelines:

Each household shall be allowed to dispose of a maximum of **two (2) sacks** of garbage per week. Garbage shall only be dumped at the MRF every **Sunday afternoon**, starting from 1:00 PM until 5:00 PM.

Only segregated waste shall be accepted; non-compliance shall result in the temporary suspension of dumping privileges.

RESOLVED FURTHER, that the Association shall hire a utility personnel to:

- Maintain order at the MRF during designated dumping hours;
- Assist in the enforcement of segregation and dumping rules;
- Ensure cleanliness and proper handling of waste at the MRF.

RESOLVED FINALLY, that said utility personnel shall receive a compensation of ₱500.00 per dumping day (Sunday), subject to availability of funds and review by the Treasurer and Audit Committee.
